Steve indicated that a full site survey was conducted and that a tree would have to be trimmed or removed to accommodate a clear line of site access. Ptera would mount an antenna to the existing railing to avoid any damage to the tank. A waterproof box would be brought in to house their equipment. All of these setup costs would be borne by Ptera. Steve indicated that a different frequency would be used to avoid any interference with the existing tank controls (operating at 900 Mhz). Pricing and terms for the residents of Hangman Hills was determined.
